

This is a publication agreement (“this agreement”) regarding a written bundle of digital conference proceedings currently entitled [XXX] (“the Conference Book”) to be published in TU Delft OPEN Publishing platform (“the platform”).

The parties to this Agreement are:

and

**TU Delft**, participating in its capacity as open access publisher under the name TU Delft OPEN

### 1. The publisher will

- a) Publish all conference proceedings under an open CC-Licence (CC-BY or CC-BY-NC): free access to all content without login/paywall. Free reuse of the content and authors retain their copyright;
- b) Provide the editor with advice and training on all technologies and systems;
- c) Apply for and assign International Book Serial Number (ISBN) and a Digital Object Identifier (DOI);
- d) Manage inclusion of the Conference Book in relevant third-party indexing platforms as Directory of Open Access Books (DOAB);
- e) Provide continuous electronic access to the Conference Book on TU Delft OPEN;
- f) Provide the editor(s) with timely notification of any technology or system changes that may impact the availability of the Conference Book;
- g) Provide a print on demand service for the Conference Book with an external party to be found on the platform of TU Delft OPEN.

### 2. The editors will

- a) Grant to the publisher a non-exclusive, worldwide license for electronic hosting and dissemination as well as for providing printing on demand services and disseminating metadata;
- b) Take full responsibility for administration issues of the Conference Book, including determining the title, mission, scope, and accepted conference papers; developing policies governing the peer review process, authors rights and responsibilities manuscript submission requirements, and style guidelines; appointing editors, reviewers, and other staff; and all other matters pertaining to the administration of the Conference Book;
- c) inform the authors and conference organisers about the publishing conditions and license;
- d) provide the Publisher with timely and correct notification of any administrative changes relevant to hosting and distribution of the Conference Book under this Agreement;
- e) grant the Publisher authority to index the Journal to Directory of Open Books (DOAB);
- f) grant the Publisher authority to apply for inclusion of the Conference Book and all contents published under this Agreement in relevant third-party indexing and abstracting services;
- g) take full responsibility for obtaining content contributors’ consent to include their material in the Conference Book under the conditions of this Agreement, and obtain necessary permissions for re-use of any third parties or non, copyrighted materials.

**3. Attribution**

the following citation to the original publication of the Conference Book is included in any attribution statement: “[year of first publication] [Title Conference Book] [Authors’ name]”, the attribution requirement of the Creative Commons license of paragraph is fulfilled.

**4. Effective date**

The effective date of this Agreement is at the moment of the signature of the editor(s) as representatives of the Conference Book and the Publisher together, and continue indefinitely unless either party provides 3 months written notice of intent to terminate.

**5. Termination**

In the event of termination of this Agreement and transfer of the Conference Book contents of the Agreement to a third party, the Publisher will cooperate fully and make all reasonable efforts to provide a smooth transition of all necessary content and metadata published or produced under this Agreement to whatever service provider the editor(s) designates.

**6. Royalties:**

TU Delft OPEN Publishing has a clear policy regarding the remuneration of its authors. As a non-for-profit publisher and service provider, we refrain from any form of royalties for authors. For that reason, there are no financial rewards for authors publishing via TU Delft OPEN.

**7. Processing charges**

At the TU Delft OPEN there are no processing charges and no publication charges for institutional author(s) and editors. Specific requests may be done at a minimum cost. These additional costs will be recovered from the editors budget. This will be done with the approval of the author(s)

**8. Claims**

You agree to indemnify TU Delft OPEN against any claim or action alleging facts which, if true, constitute a breach of any of the foregoing warranties or other provisions of this agreement, as well as against any related damages, losses, liabilities, and expenses incurred by TU Delft OPEN. This indemnity also applies to any photographs, drawings or other illustrations supplied by you in the Conference Book

**9. If you desire to publish the Conference Book in print, TU Delft OPEN will provide a third party. TU Delft OPEN will not act as a printing partner themselves.****10. This is the entire agreement between editors of the Conference Book and TU Delft OPEN, and it may be modified only in writing. It will be governed by the laws of the Netherlands and any disputes about it will be settled by the Dutch courts. It will bind and benefit your respective assigns and successors in interest, including your heirs. It will terminate if TU Delft OPEN does not publish the Conference Book in any medium within one year of the date of your signature.**
